Templeton Chamber of Commerce is proud to present the 8th annual “Day in the Shade” fine art and craft outdoor festival. The festival will take place on Saturday, May 8th, 2010, from 9 - 5pm, in Templeton Park. This event runs in conjunction with Farmers Market in the morning, and there will be a variety of activities and entertainment in the Park in the afternoon.

JURY SELECTION: Each artist’s work will be judged based on quality and originality. Only work created by the applying artist will be considered. Please send 4 photographs of artwork with application. *No slides.* Please include a **SASE**, and if sending us photos, include sufficient postage for return of photos. Small format j-pegs may be sent via e-mail to ekwatercolors@yahoo.com . ***Please submit quality photos or jpegs even if you have been accepted before!***

Jury dates will be February 15th, March 1st, 15th, and 31st. *We strongly recommend that jewelers in particular apply early – last year we had to turn away several very qualified artists because we had filled the quota for that medium.*

“BUY & SELL” work is PROHIBITED!!! If work produced by anyone other than yourself is found in your booth, you **will** be asked to leave the show. ***Please initial here to indicate agreement and acceptance: _____***

SET UP: Set up Saturday morning. Instructions will be mailed with acceptance letters. *Note:* Canopies (if used) and displays must be fire retardant. ***Canopies must be WHITE.*** Electricity is **not** available. Early breakdown is not permitted.

ENTRY FEE DEADLINE: March 31, 2009

Earlybirds: (***Must be postmarked by March 15th***): \$95 for 10’x10’ space, \$160 for 10’x20’ space.

Entries postmarked between March 16th and 31st: \$115 for 10’x10’ space, \$195 for 10’x20’ space.
